ORDINANCE NO. 7840

AN ORDINANCE relating to the annexation of an area known as P-290R to Cascade Sewer District, amending Ordinance No. 7638, Section 4.

SECTION 1. Ordinance No. 7638, Section 4 is hereby amended to read as follows:

Being a portion of Section 25, Township 22 North, Range 5 East, W.M. and Section 36, Township 22 North, Range 5 East, W.M., in King County, Washington, more fully described as follows:

Beginning at the intersection of the extension of the Southerly margin of Primary State Highway No. 2 (State Route 18) and the East line of said Section 25, said point also being on the existing Cascade Sewer District boundary line;

Thence Southerly along said East line to the South line of said Section 25, also being the North line of said Section 36;

Thence West along said South line of Section 25 to a point of intersection with the Northwest margin of S.E. Wax Road extended;

Thence Southwest along said Northwest margin to the North line of Covington Homes as recorded in Volume 89 of Plats, Page 6, records of King County, Washington;

Thence West 637.59 feet along said North line to the East line of Covington Firs as recorded in Volume 100 of Plats, Pages 100 and 101, records of King County, Washington;

Thence North 901.81 feet along said East line to the Northern most line of said Covington Firs;

Thence West along said Northern line of Covington Firs to the West line of the East 1/2 of the Northwest 1/4 of the Northwest 1/4 of Section 36;

Thence North along said West line to the Southerly margin of Frontage Road (Covington Way S.E.);

Thence Northerly along said margin to the South margin of S.E. 272nd Street (S.E. Kent-Kangley Road);

Thence East along said margin line to the East line of the West half of the Northwest quarter of said Section 36;

Thence North 380 feet, more or less, along said East line and the East line of the West half of the Southwest quarter of said Section 25 to the South line of Berger Addition as recorded in Volume 69 of Plats, Page 67, records of King County, Washington;

Thence East 492.92 feet along said South line to the centerline of 169th Place S.E.;

1 Thence North along said centerline of 169th Place S.E. to the
2 South line of Lot 1 extended of Fir Acres No. 1 as recorded in
Volume 106 of Plats, Pages 45 and 46, King County, Washington;

3 Thence East along said South line extended also being the
4 centerline of Southeast 270th Place extended to the East line
of Fisher's Addition as recorded in Volume 70 of Plats, Page
84, records of King County, Washington;

5 Thence North 866.7 feet along said East line of Fisher's
6 Addition to the South line of Burwood Park as recorded in
7 Volume 83 of Plats, Pages 88 and 89, records of King County,
Washington;

8 Thence East 965.40 feet to the East line of said Burwood Park;

9 Thence North along said East line of said Burwood Park and the
10 West line of the East 1/2 of the Northeast 1/4 of said Section
25 to the southerly margin of Primary State Highway No. 2
(State Route 18);

11 Thence Northeast along said margin to the True Point of
12 Beginning.
