

ORDINANCE NO. 7859

AN ORDINANCE establishing monthly parking fees collected on behalf of the Stadium Enterprise Fund; amending Ordinance 7017, Section 4, and K.C.C. 22.12.030, and adding a new section.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

NEW SECTION. SECTION 1. Effective Date. The effective date of this ordinance is January 1, 1987.

SECTION 2. Ordinance 7017, Section 4, and K.C.C. 22.12.030 are hereby amended as follows:

Parking.

A. Daily Parking Fees

Any person parking a vehicle in the Kingdome parking lot on a daily basis will pay according to the following schedule:

1. Non-Event Day Parking:

Days, 0 to 3 hours. \$2.00 per parking stall (includes sales tax)

Days, over 3 hours. \$4.00 per parking stall (includes sales tax)

Evenings. \$2.00 per parking stall (includes sales tax)

2. Event Day Parking:

Vehicles under 23 feet in length. \$4.00 per event (includes sales tax)

Vehicles 23 feet in length and over (except buses) \$8.00 per event (includes sales tax)

Buses \$10.00 per event (includes sales tax)

B. Monthly Parking Fees

Any person or organization choosing to park a vehicle in the Kingdome north parking lot on a monthly basis, will pay according to the following schedule:

- 1. Individual Rate . . (~~(\$35)~~) \$40 per parking stall
plus sales tax

The individual rate allows parking from 5:00 a.m. to 12:00 a.m. on non-event days; parking is also permitted on event days based on times established by the stadium's department director.

- 2. Group Rate (~~(\$30)~~) \$35 per parking stall
plus sales tax

The group rate allows any person or organization using five or more parking stalls to park from 5:00 a.m. to 12:00 a.m. on non-event days; parking is also permitted on event days based on times established by the stadium's department director.

- 3. Unrestricted Rate . (~~(\$45)~~) \$50 per parking stall
plus sales tax

The unrestricted rate allows parking from 5:00 a.m. to 12:00 a.m. on all non-event and event days.
