ORDINANCE NO. 1987

AN ORDINANCE relating to the annexation of an area known as Number 16 to Northeast Sammamish Sewer and Water District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Number 16 to Northeast Sammamish Sewer and Water District was filed with the county council effective December 16, 1987.

2. Northeast Sammamish Sewer and Water District has found the petition for annexation to be sufficient and has, by Resolution No. 1294 concurred with the proposed annexation.

3. Northeast Sammamish Sewer and Water District filed a Declaration of Non-significant Impact dated August 13, 1986, on the proposed annexation.

4. The county council held a public hearing on the 23rd day of February, 1987 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Northeast Sammamish Sewer and Water District of the area known as Number 16 and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on Number 16.

SECTION 2. The Northeast Sammamish Sewer and Water District is the appropriate entity to serve the area proposed to be annexed

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

1 SECTION 4. The area known as Number 16 to be annexed is
2 described as follows:

3 The portion of Section 27, Township 25 North, Range 6 East,
4 W.M., King County, Washington, described as follows:

5 Beginning at the Northwest corner of the NE 1/4 of Section 27,
6 Township 25 North, Range 6 East, W.M.,

7 Thence East along the North line of said Section to the
8 Northeast corner of the NW 1/4 of the NE 1/4 of said Section;

9 Thence South along the East line of the NW 1/4 of the NE 1/4
10 of said section to the Southeast corner of the N 1/2 of the S
11 1/2 of the NW 1/4 of the NE 1/4 of said Section;

12 Thence West along the South line of the N 1/2 of the S 1/2 of
13 the NW 1/4 of the NE 1/4 of said Section to the Southwest
14 corner therof;

15 Thence North along the West line of the NE 1/4 of said Section
16 to the Point of Beginning.

17 EXCEPT: Tax Lot No. 67 of said Section 27, described as
18 follows:

19 The E 1/2 of the E 1/2 of the N 1/2 of the NW 1/4 of the NE
20 1/4 of said Section.
