ORDINANCE NO. _____

AN ORDINANCE relating to the annexation of an area known as Ross to Woodinville Water District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as Ross to Woodinville Water District was filed with the county council effective April 3, 1987.

2. Woodinville Water District has found the petition for annexation to be sufficient and has, by Resolution No. 2182 concurred with the proposed annexation.

3. Woodinville Water District filed a Declaration of Non-significant Impact dated August 12, 1987, on the proposed annexation.

4. The county council held a public hearing on the 4th day of May, 1987 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Woodinville Water District of the area known as Ross and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on Ross.

SECTION 2. Woodinville Water District is the appropriate entity to serve the area proposed to be annexed.

1 SECTION 3. Completion of this annexation does not constitute
2 county approval or disapproval of any other permits, certifica-
3 tions, or actions necessary to provide service to this annexation
4 area.

5 SECTION 4. The area known as Ross to be annexed is described
6 as follows:

7 Those portions of Section 19, Township 26 North, Range 6 East,
8 W.M., lying West of the East margin of Avondale Road,
described as follows:

9 The Southeast quarter of the Northwest quarter of said Section
10 19, and

11 The Northeast quarter of the Southwest quarter of said section
12 19, and

13 The Northwest quarter of the Northeast quarter of said Section
14 19, and

15 The Southwest quarter of the Northeast quarter of said Section
16 19, and

17 The Northwest quarter of the Southeast quarter of said Section
18 19, all situated in King County, Washington.
