ORDINANCE NO. 18106

AN ORDINANCE relating to the annexation of an area known as P-289R to Cascade Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as P-289R to Cascade Sewer District was filed with the county council effective March 5, 1987.

2. Cascade Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 2455 concurred with the proposed annexation.

3. Cascade Sewer District filed a Declaration of Non-significant Impact dated February 5, 1987, on the proposed annexation.

4. The county council held a public hearing on the 10th day of May, 1987 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Cascade Sewer District of the area known as P-289R and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on P-289R.

SECTION 2. The Cascade Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

1            SECTION 4. The area known as P-289R to be annexed is  
2 described as follows:

3            Beginning at the Northwest corner of the Southeast quarter of  
4 Section 34, Township 23 North, Range 5 East, W.M., in King  
5 County, Washington. Said point being on the existing boundary  
of Cascade Sewer District;

6            Thence Easterly along the North line of the Southeast quarter  
of said Section 34 to the East line of said Section 34;

7            Thence Southerly along said East line to the South line of the  
8 North 495.00 feet of the East half of the Southeast quarter of  
the Southeast quarter of said Section 34;

9            Thence Westerly along said South line to the West line of the  
10 East half of the Southeast quarter of the Southeast quarter of  
said Section 34;

11           Thence Northerly along said West line to the South line of the  
12 North 440.00 feet of the West half of the Southeast quarter of  
the Southeast quarter of said Section 34;

13           Thence Westerly along said South line to the West line of the  
14 East half of the Southeast quarter of said Section 34;

15           Thence Northerly to a point on said West line which is 898.82  
16 feet North of the South line of said Section 34 as measured  
along said West line;

17           Thence Westerly and parallel with the South line of said  
18 Section 34 to the West line of the Southeast quarter of said  
Section 34;

19           Thence Northerly along said West line to the Point of  
20 Beginning.
