

ORDINANCE NO. 8327

AN ORDINANCE relating to fees charged for the use of King County Parks and Recreation Facilities and amending ordinance No. 7860, as amended, and K.C.C. 7.08.020 through K.C.C. 7.08.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 7860, Section 2, and K.C.C. 7.08.020 are amended to read as follows:

A. Swimming Pool Fees (fees include sales tax).

- Public Swims: 17 and under . . . (~~\$.75~~) \$1.00 per person per session
- 18 and over . . . (~~\$1.25~~) 1.00 per person per session
- (~~Twenty-Five~~) Fifty Cent Swims. (~~\$.25~~) .50 per person per session
- Adult Only Swims . . . . . (~~\$1.25~~) 1.50 per person per session
- Senior Citizens-60 plus years . . (~~\$.75~~) 1.00 per person per session

19 SECTION 3. Ordinance No. 7860, Section 4, and K.C.C. 7.08.040 are amended

21 RECREATION SERVICES. Recreation service fees shall be:

22 A. Fee structured program

23 Class Fees . . . . . Range \$5.00 to \$50.00 per class

24 A ten percent administrative surcharge not to exceed \$5.00 will be  
 25 assessed per participant per registration on the class or event cost  
 26 for all fee structured classes special events, athletic fee  
 27 programs, workshops, special events or seminars. This  
 28 administrative cost will not be charged for regularly scheduled  
 29 programs or events which are intended solely for the enjoyment of  
 30 citizens 55 years or older.

31 B. Entry and tournament fees (Leagues, tournament and special events fees

1 to include officials, awards, sports equipment, administration fees and  
 2 association fees.)

3 Adult Men's/Women's Leagues . . . . . \$100 - \$600 per team/league

4 Adult Men's/Women's Tournaments . . . . . \$50 - \$200 per team/league

5 Individual dual sports events . . . . . \$5 - \$50 per participant

19 1. Group A - Activity Center Only

20 Includes meetings or activities that are promoted, organized,  
 21 managed, supervised and sponsored by civic or nonprofit  
 22 organizations such as community clubs, Orthopedic Guilds, service  
 23 clubs, and public meetings. If the activity under sponsorship is  
 24 open and free to the public and conforms to the rules of the  
 25 activity center and is scheduled during the activity center program  
 26 hours, there is no charge.

27 2. Group B - Activity Centers and Community Centers

28 (For any organizations, groups and clubs, using an activity or  
 29 community center during nonprogram hours, or a community center at  
 30 any time during the day or evening, the following fee schedule will  
 31 be applied.)

Gymnasium fee . . . . . \$15.00 per hour (2 hour minimum)

Meeting room fee . . . . . \$10.00 per hour (2 hour minimum)

3. Group C - Kitchen Use Fee (All facilities except Clise Mansion)

(Facility users will not be assessed a kitchen fee to obtain water for coffee pots).

Kitchen use fee . . . . . \$5.00 per hour (2 hour minimum)

4. Group D - Gold Creek Lodge Use Fee

(Any group renting the facility for less than one day will use the Group B fee schedule. For groups using the facility for 24 hours or more the following fee schedule will be used).

Youth Groups . . . . . \$ 50.00 per day

Adult Groups . . . . . 100.00 per day

5. Group E - Clise Mansion Use Fees

a. Rental of entire mansion except kitchen and museum

Wednesday - Sunday, March - October . . . \$180/2-6 hours

(Any groups renting outdoor facilities for activities including, but not limited to, dog shows, outdoor weddings, day camps, Fun Runs and organized picnics will pay according to the following fee schedule.)

1 - 100 participants . . . . . \$20.00 per day

101 + participants . . . . . .20¢ per participant per day

Any groups using outdoor facilities who charge a participant fee will be assessed the above rental rate plus 10% of gross revenue.

All groups will be assessed a \$2.00 handling fee per Reservation Form.

Groups renting facilities for special use activities such as, but not limited to, the Kool Jazz Festival or the Velodrome Bicycle Track Program shall pay fees determined through negotiated contract.

For any organizations, groups, or clubs using an activity center or community center, power fees and a damage and key deposit fee may be assessed according to the following schedule.

- Power fees . . . . . \$10.00 to \$15.00 per day
- Damage deposit . . . . . \$25.00 to \$200.00  
(determined by type of activity and number of participants)
- Key deposit . . . . . \$25.00 to \$50.00  
(determined by type of activity and number of participants)

- Moorage fees . . . . . \$5.50 per night (including tax)
- For boats 26 feet in length and over
- \$3.50 per night (including tax)
- For boats under 26 feet in length
