ORDINANCE NO. **8780**

AN ORDINANCE making an appropriation of \$70,409 to the Department of Youth Services for specific maintenance projects and \$13,125 to establish a new capital improvement project from funds previously allocated to CIP Project No. 666041, Youth Service Center Special Program Unit Remodel, and CIP Project No. 666039, Youth Service Center Surveillance Upgrade.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$13,125 to the Intrusion Detection System CIP Project No. 666045 in the Youth Services Facilities Construction Fund (Fund 335) from a transfer from CIP Project No. 666041, Youth Service Center Special Programs Unit Expansion in the Youth Services Facilities Construction Fund (Fund 335) for the purpose of installing an intrusion detection system for the department of youth services complex.

SECTION 2. There is hereby approved and adopted an appropriation of \$70,409 to the department of youth services in the Current Expense Fund from the Youth Service Center Facilities Construction Fund (Fund 335) from CIP Project No. 666041, Youth Service Center Special Programs Unit Expansion, and CIP Project No. 666039, Youth Service Center Surveillance Upgrade, for the purpose of installing 24 locks on cells in Alder, installing 30 steel doors with security locks in Alder cells, installing 16 doors and locks in Spruce, repair of control consoles in Spruce, installation of a watch tour system in Alder, and renovation of the health clinic's observation room.

SECTION 3. Ordinance No. 8331, Section 80, as amended, is hereby amended by adding thereto and inserting therein the following:

From the several capital improvement program funds, there are hereby appropriated and authorized to be disbursed the following amounts for the spe-

1 cific projects identified in Attachment No. 1 as adjusted by Attachment No. 2
2 of Ordinance No. 8331.
