ORDINANCE NO.

AN ORDINANCE relating to paid parking in county owned parking facilities, establishing fees and amending Ordinance No. 8753, Sections 1 and 6, and K.C.C. 3.32.020.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 8753, Section 1, as amended and K.C.C. 3.32.020 are amended to read as follows:

Parking Fees - General. A. All county employees and elected officials who are assigned the regular use of a parking stall, or who are authorized the use of available unassigned parking stalls on a regular basis while engaged in county business, within any of the county-owned parking facilities, shall pay parking fees as provided in this chapter. Parking fees shall not be paid by the county in behalf of any individual employee or elected official who is assigned the regular use of a county parking stall regardless of whose vehicle that person parks in the stall. Current county employees covered by existing collective bargaining agreements shall be effected only in a manner consistent with state law.

B. Method of payment. Such parking fees shall be paid through monthly payroll deductions from the wages of the employee or elected official who is assigned the regular use of the county parking stall regardless of whether that person is assigned the use of a county owned vehicle, assigned a vehicle provided at county expense, or uses a privately-owned vehicle.

C. Optional survey. The department of executive administration may conduct a survey of the monthly parking rates charged for public parking in lots of ten or more spaces within the area bounded by Jackson Street on the south, Sixth Avenue on the east, Columbia Street on the north and Second Avenue on the

1 west. Such survey and any parking fee recommendations shall be  
2 forwarded to the council for consideration during the budget  
3 process.

4 SECTION 2. Ordinance 8753, Section 6, is hereby amended to  
5 read as follows:

6 Parking Rates - Surface Parking Lots. The parking rates for  
7 (~~daily~~) parking in designated open surface parking lots shall  
8 be as follows:

9 A. Daily general parking on county business which exceeds  
10 the two hour limit, general public parking not on county  
11 business, and county employees not assigned regular parking  
12 stalls:

14 0- 2 hours \$3.00

15 2- 4 hours \$5.00

16 4-10 hours \$7.00

17 Special events \$6.00

18 2. Evenings after 6 p.m. and all day

19 Saturday, Sunday and legal holidays

21 B. Assigned parking for county employees in open surface  
22 parking lots:

23 Effective January 1, 1989.....\$50.00 per month
