5 AN ORDINANCE making appropriations of \$307,083 to the human  
6 services fund-mental health program, from additional revenues  
7 from the Washington State Department of Social and Health  
8 Services to develop supported employment services and provide  
9 case management services to homeless persons with severe psy-  
10 chiatric disabilities; \$43,462 to the department of human  
11 resources administration from the Federal Head Start Program  
12 and the State of Washington WIN Program revenues to develop a  
13 technical assistance package for child care providers, and  
14 from the carryover of unexpended 1988 Human Services  
15 Roundtable revenue received from various suburban cities for  
16 the continuation of this planning project in 1989; and  
17 amending Ordinance No. 8802, Sections 51 and 60, as amended.

18 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

19 SECTION 1. There is hereby approved and adopted an appropriation of  
20 \$307,083 to the human services fund--mental health program from additional  
21 revenues from the State of Washington Department of Social and Health Services  
22 to develop supported employment services and provide case management services  
23 to homeless persons with severe psychiatric disabilities.

24 SECTION 2. There is hereby approved and adopted an appropriation of  
25 \$43,462 to the department of human resources administration from the Federal  
26 Head Start Program and the State of Washington WIN Program revenues to develop  
27 a technical assistance package for child care providers, and from the  
28 carryover of unexpended 1988 Human Services Roundtable revenue received from  
29 various suburban cities for the continuation of this planning project in 1989.

30 SECTION 3. Ordinance No. 8802, Section 51, as amended, is hereby amended  
31 by adding thereto and inserting therein the following:

32 DEPARTMENT OF HUMAN RESOURCES ADMINISTRATION - From the Current Expense  
33 Fund there is hereby appropriated to:

Department of Human Resources Administration \$43,462

34 SECTION 4. Ordinance No. 8802, Section 60, as amended, is hereby amended


