ORDINANCE NO. **9114**

AN ORDINANCE relating to the establishment of South/Southwest 356th Street from 21st Avenue Southwest to Pacific Highway South and repealing Ordinance 8807.

BE IT ORDERED BY THE COUNCIL OF KING COUNTY:

Section 1: Ordinance 8807 relating to the establishment of South/Southwest 356th Street from 21st Avenue Southwest to Pacific Highway South is hereby repealed in its entirety.

Section 2: The director of the department of public works has made an examination of South/Southwest 356th Street between 21st Avenue Southwest and Pacific Highway South along the course and description set forth below and has made a favorable report upon the same, as required by RCW 36.81.050.

Section 3: Said road shall be established not less than 84 feet in width, having 42 feet of such width each side of the following described centerline:

Commencing at the northeast corner of Section 25, Township 21 North, Range 3 East, W.M.; thence S 0° 44' 51" W along the east line thereof a distance of 1328.07 feet to the S.E. corner of the NE ¼ of the NE ¼ of said Section 25 and the center line of Southwest 356th Street; thence N 87° 20' 50" W, a distance of 1327.36 feet to a point on the center line of 21st Avenue Southwest and the point of beginning of the herein described road establishment; thence S 87° 20' 50" E a distance of 1327.36 feet to the east line of Section 25, Township 21 North, Range 3 East, W.M.; thence S 89° 02' 26" E, a distance of 2005.19 feet; thence along an arc of a curve to the right having a radius of 660.00 feet, a distance of 328.66 feet; thence S 60° 30' 32" E, a distance of 316.13 feet; thence along an arc of a curve to the left having a radius of 660.00 feet, a distance


