ORDINANCE NO. **9136**

AN ORDINANCE making an appropriation to several agencies for the purpose of paying for goods or services planned but not delivered or not paid for during the previous fiscal year, and amending Ordinance No. 8802, Sections 44, 54, 55, 57, 65, 68, 71, 76, 77, 84, 88 and 90.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:




