ORDINANCE NO. 9314

AN ORDINANCE relating to the annexation of an area known as 313R-S to Soos Creek Water and Sewer District for sewer service.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as 313R-S to Soos Creek Water and Sewer District for sewer service was filed with the county council effective December 14, 1989.

2. Soos Creek Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 0389-S concurred with the proposed annexation.

3. Soos Creek Water and Sewer District filed a Declaration of Non-significant Impact dated September 21, 1989, on the proposed annexation.

4. The county council held a public hearing on the 8th day of JANUARY, 19 90 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Soos Creek Water and Sewer District for sewer service of the area known as 313R-S and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on 313R-S.

SECTION 2. The Soos Creek Water and Sewer District is the appropriate entity to serve the area proposed to be annexed for sewer service.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this

1 annexation area, nor does it authorize sewer service in any area
2 not designated as a "Local Service Area" by the King County
3 Sewerage General Plan.

5 SECTION 4. The area known as 313R-S to be annexed is
6 described as follows:

7 Beginning at the Northwest corner of the Northeast quarter of
8 Section 25, Township 22 North, Range 5 East, W.M., in King
9 County, Washington, said point being on the existing boundary
10 of the Soos Creek Water and Sewer District;

11 Thence Easterly, along the North line of said Northeast
12 quarter, said line also being the centerline of Southeast
13 256th Street, to the West line of the East half of the East
14 half of said Northeast quarter;

15 Thence Southerly, along said West line, to the North line of
16 the South half of the South half of the Northeast quarter of
17 the Northeast quarter of said Section 25;

18 Thence Easterly, along the North line, to the East line of
19 said Section 25;

20 Thence Southerly along said east line of Section 25, said line
21 also being the centerline of 180th Avenue Southeast, to the
22 South line of the North half of the Northeast quarter of said
23 Section 25;

24 Thence Westerly, along said South line, to the West line of
25 the East half of the West half of the Northwest quarter of the
26 Northeast quarter of said Section 25;

27 Thence Northerly, along said West line, to the North line of
28 the Northeast quarter of said Section 25;

29 Thence Westerly, along said North line, to the POINT OF
30 BEGINNING.
