3 AN ORDINANCE establishing an Open Space Projects  
4 Administration Sub-Fund within the Open Space Projects  
5 Acquisition and Improvement Fund and appropriating \$3,000  
6 to the 1990 Series B Youth Detention Facility Fund; \$7,000  
7 to the 1990 Series B West Seattle Bridge Construction Fund  
8 - Phase II; and \$175,000 to the Open Space Projects  
9 Administration Sub-Fund from bond proceeds for payment of  
10 financial advisory services and bond counsel for the 1990  
11 Unlimited G.O. Open Space bond issue and 1990 various purpose  
12 limited G.O. bond issue; and amending Ordinance No. 9221,  
13 Section 92, as amended.

14 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

15 SECTION 1. There is hereby authorized and directed to be created in  
16 the office of financial management of the county the Open Space Projects  
17 Administration Sub-Fund, a sub-fund of the Open Space Projects Acquisition  
18 and Improvement Fund, into which shall be deposited approximately \$175,000  
19 and which shall be used to pay debt issuance costs of the Open Space  
20 Unlimited General Obligation Bonds.

21 SECTION 2. There is hereby approved and adopted an appropriation of  
22 \$175,000 to the Debt Issuance Cost Project in the Open Space Projects  
23 Administration Sub-Fund from bond proceeds for payment of financial  
24 advisory services and bond counsel for the 1990 Open Space unlimited G.O.  
25 bond issue.

26 SECTION 3. There is hereby approved and adopted an appropriation of  
27 \$3,000 to the Debt Issuance Cost Project in the 1990 Series B Youth  
28 Detention Facility Fund from bond proceeds for payment of financial  
29 advisory services and bond counsel for the 1990 various purpose limited  
30 G.O. bond issue.

31 SECTION 4. There is hereby approved and adopted an appropriation of  
32 \$7,000 to the Debt Issuance Project in the 1990 Series B West Seattle  
33 Bridge Construction Fund - Phase II from bond proceeds for payment of  
financial advisory services and bond counsel for the 1990 various purpose  
limited G.O. Bond issue.

SECTION 5. Ordinance No. 9221, Section 92, as amended, is hereby  
amended by adding thereto and inserting therein the following:

From the several capital improvement project funds there is hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment 1 of this ordinance.
