ORDINANCE NO. **9446**

AN ORDINANCE relating to the annexation of an area known as 82-4 to Southwest Suburban Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as 82-4 to Southwest Suburban Sewer District was filed with the county council effective April 9, 1990.

2. Southwest Suburban Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 90-5 concurred with the proposed annexation.

3. Southwest Suburban Sewer District filed a Declaration of Non-significant Impact dated December 28, 1989 on the proposed annexation.

4. The county council held a public hearing on the 25<sup>th</sup> day of April, 1990 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Southwest Suburban Sewer District of the area known as 82-4 and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report on 82-4.

SECTION 2. The Southwest Suburban Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

SECTION 4. The area known as 82-4 to be annexed is described  
 as follows:

That portion of the Northwest 1/4 of Section 29, Township 23 North, Range 4 East, W.M., described as follows:

Beginning at the Northeast corner of the Northwest 1/4 of said Section 29;

Thence Southerly along the East line thereof to its intersection with the South line of the Northwest 1/4 of said Section 29;

Thence Westerly along said South line to its intersection with the East margin of SR-509;

Thence Northwesterly along said East margin to the Centerline of Des Moines Way South;

Thence Northerly and Easterly along said centerline to its intersection with the North line of the Northwest 1/4 of said Section 29;

Thence Easterly along said North line to its intersection with the Northeast corner thereof and the Point of Beginning.
