AN ORDINANCE relating to the traffic code, prohibiting the parking of detached trailers or vehicles with attached trailers on any streets or portions thereof; including N.E. 130 Place and amending Ordinance No. 7403 and K.C.C. 46.04.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 7403, Section 1 and K.C.C. 46.04.060

are each hereby amended to read as follows:

RCW 46.61.570-1 amended. RCW 46.61.570-1 is amended as follows:

A. When signs are erected in each block giving notice thereof, no person shall park a vehicle:

1. At any time upon any of the streets or ports thereof described in Schedule 14 of this traffic code.

2. Between the hours specified in Schedule 15 of any day except as provided within the district or upon any of the streets described in said schedule.

3. Or stop or stand a vehicle between the hours specified in Schedule 16 of any day except as provided in said schedule within the district or upon any of the streets described in said schedule.

4. For a period of time longer than specified in Schedule 17 upon any of the streets specified in said schedule.

~~5. At any time with an attached trailer upon any of the streets or portions thereof described in Schedule 18 of this traffic code.~~

B. No person shall park a commercial vehicle which is more than 80 inches wide overall on any street or alley in residentially-zoned areas as defined in Title 21 between the hours of midnight and six a.m.

1 C. When signs are erected in each block giving notice
2 thereof, no person shall park a trailer, either attached to or
3 detached from a motor vehicle at any time, upon any of the
4 streets or portions thereof described in Schedule 18 of this
5 traffic code.

6 SECTION 2. Pursuant to traffic engineering studies, and as
7 authorized by RCW 46.90, Schedule 18 of King County Ordinance
8 7403 as amended by this ordinance, is amended to add the
9 following location:

10 NORTHEAST 130TH PLACE, on both sides, from its western end
11 point through the point of intersection with Holmes Point Drive
12 Northeast to a point 50 feet northeast of 63rd Avenue
13 Northeast.
