

ORDINANCE NO. **9965**

AN ORDINANCE making an appropriation of \$193,400 to the finance division for bond issue costs and making appropriations from several CIP funds to reimburse the Current Expense Fund for those costs, and amending Ordinance 9270, Sections 16 and 94, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$193,400 to the finance division from the unappropriated fund balance of the Current Expense Fund for bond issue costs and to pay for costs of issuing Series 1991 A, B, and C bonds.

SECTION 2. There is hereby approved and adopted appropriations to several capital funds as follows: \$25,000 from the Zoo Development Fund; \$55,000 from the Solid Waste Construction 1989 Fund; \$9,300 from the Equipment Acquisition 1991 Fund; \$39,100 from the Building Acquisition 1991 Fund; \$60,000 from the Pacific Medical Center Project Construction 1991 Fund; and \$5,000 from the Kingdome Construction Fund from the unappropriated balances of those funds for the purposes of reimbursing the Current Expense Fund for costs of bond issuance.

SECTION 3. Ordinance 9720, Section 16, is hereby amended by adding thereto and inserting therein the following:

FINANCE - From the Current Expense Fund there is hereby appropriated to:  
Finance \$193,400

SECTION 4. Ordinance 9720, Section 94, as amended, is hereby amended by adding thereto and inserting the following:

CIP PROJECT APPROPRIATIONS - From the several capital improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts.
