ORDINANCE NO. **10098**

AN ORDINANCE relating to the annexation of an area known as 319-W to Soos Creek Water and Sewer District for water service.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area for sewer service known as 319-W to Soos Creek Water and Sewer District was filed with the county council effective August 7, 1991.

2. Soos Creek Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 0677-W concurred with the proposed annexation.

3. Soos Creek Water and Sewer District filed a Declaration of Non-significant Impact dated June 6, 1991, on the proposed annexation.

4. The county council held a public hearing on the 3rd day of September, 1991 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Soos Creek Water and Sewer District of the area known as 319-W and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 57.02.040 as described in the attached King County Council Annexation Report on 319-W.

SECTION 2. The Soos Creek Water and Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, certifications, or actions necessary to provide service to this annexation area.

SECTION 4. The area known as 319-W to be annexed is described as follows:

That portion of the Southwest quarter of the Northeast quarter of Section 7, Township 22 North, Range 5 East, W.M., King County, Washington, described as follows:

Beginning at a point at the intersection of the South line of said Southwest quarter and the East line of the West 264.90 feet of the Southeast quarter of the Southwest quarter of the Northeast quarter of said Section 7, also being a point on the Soos Creek Water and Sewer district boundary;

1 Thence Northerly, along said East line and said District
2 boundary, to the South line of the Northeast quarter of the
3 Southwest quarter of the Northeast quarter of said Section 7;

4 Thence Westerly along the South line and said District
5 boundary, to the East line of the West 100 feet of the
6 Northeast quarter of the Southwest quarter of the Northeast
7 quarter of said Section 7;

8 Thence Northerly, along said East line and said District
9 boundary, to the South line of the North half of the Northeast
10 quarter of the Southwest quarter of the Northeast quarter of
11 said Section 7;

12 Thence Easterly, along said line and said District
13 boundary, to the East line of the West 130.00 feet of the
14 Northeast quarter of the Southwest quarter of the Northeast
15 quarter of said Section 7;

16 Thence Northerly, along said East line and said District
17 boundary, to the North line of the Southwest quarter of the
18 Northeast quarter of said Section 7;

19 Thence Westerly, along said North line and said District
20 boundary, to its intersection with the Northerly extension of
21 the centerline of 94th Place South;

22 Thence Southerly along said Northerly centerline extension,
23 and the centerline of 94th Place South, to the South line of
24 the Southwest quarter of the Northeast quarter of said Section
25 7;

26 Thence Easterly, along said South line, to the Point of
27 Beginning.

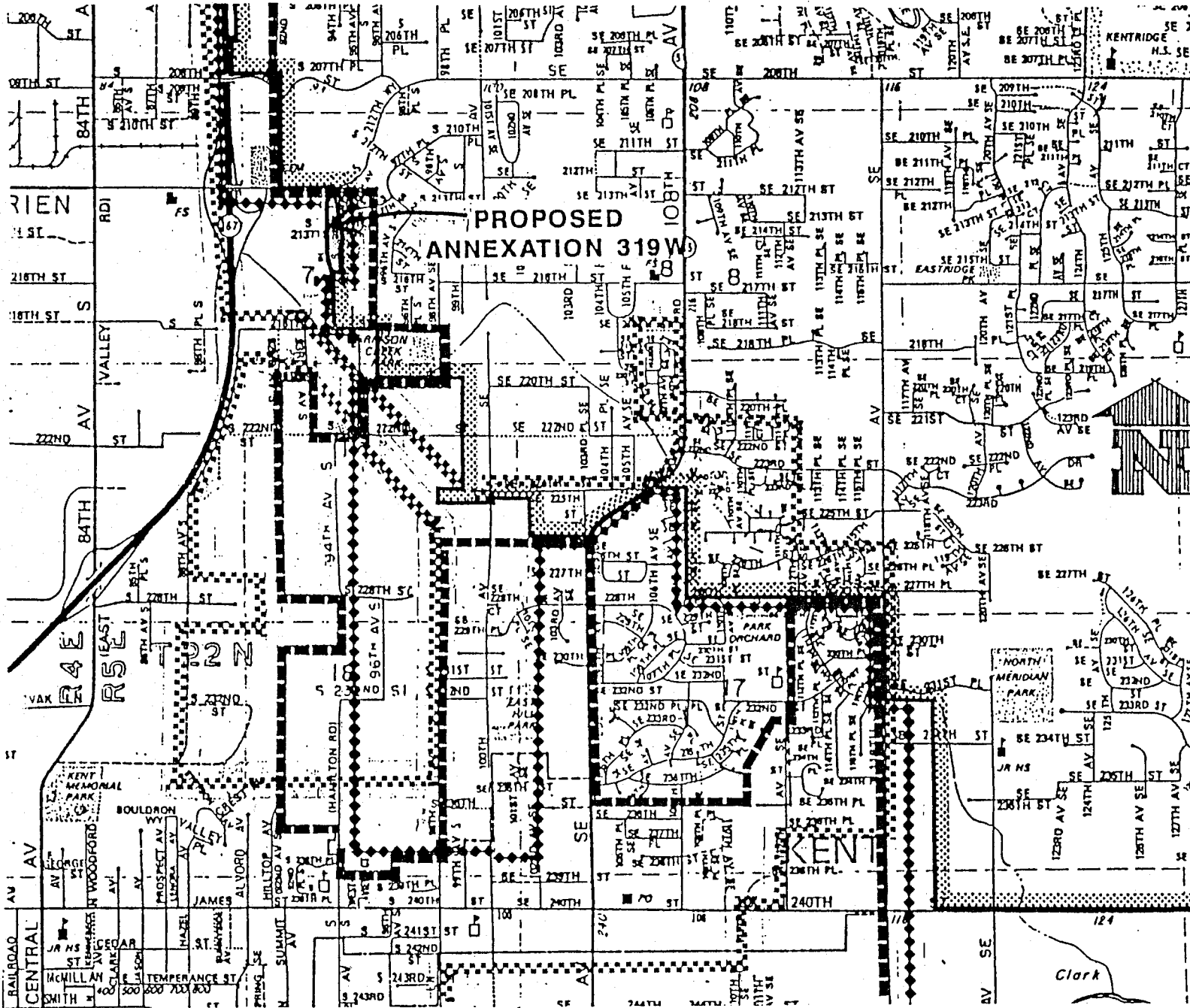
