AN ORDINANCE making supplemental appropriations of \$90,197 to the Clinic Construction Fund for Artworks at three Health Clinics and \$73,000 to the 1% for Art Fund for Artworks at Enumclaw and Hobart Transfer Stations; and amending Ordinance No. 9720, Section 94 and Attachment 1, as amended.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$90,197 to Fund 313, the Clinics Construction Fund, from unallocated bond proceeds of Fund 313 to support the design, construction and installation of art works associated with three health clinics located in the Eastgate, Totem Lake and Federal Way areas of King County; and \$73,000 to the 1% for Art Fund for Artworks associated with Enumclaw and Hobart Transfer Stations from unappropriated Solid Waste 1991 Series A Bond Proceeds, which are assigned to Artworks and deposited in Fund 3202.

SECTION 2. Ordinance No. 9720, Section 94 as amended, is hereby amended by adding thereto and inserting therein the following:
