AN ORDINANCE appropriating the remaining balance of the Zoo Development 1986 Bonds Subfund and the proceeds and accumulated interest from the 1991 Zoo Development Bond issue from unappropriated fund balance for the purpose of completing the Woodland Park Zoo Development program as defined by the Financing and Development Plan as amended, and amending Ordinance No. 9720, Section 94 and Attachment 1, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$500,000 to CIP Project No. 038000 (Woodland Park Zoo Development Program) from estimated unencumbered fund balance in Zoo Development 1986 Bonds, Subfund No. 311 and \$9,500,000 to CIP Project No. D10129 (Woodland Park Zoo Development Program) from estimated unencumbered fund balance in the 1991 Zoo Development Bond, Fund No. 3112 for:

SECTION 2. Ordinance No. 9720, Section 94, Attachment 1, as amended, is hereby amended by adding thereto and inserting therein the following:
