AN ORDINANCE making a supplemental appropriation of \$177,961 to the department of youth services/criminal justice from Special Programs-Executive Contingency (Criminal Justice Funds) for funding the implementation of the first phase DYS-(criminal justice)Local Area Network; and amending Ordinance No. 9720, Sections 32 and 36, as amended, and Ordinance No. 10179, Section 22, and disappropriating \$53,553 from the Youth Services/Criminal Justice Fund.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$177,961 to the department of youth services/criminal justice from special programs-executive contingency (Criminal Justice Funds) for funding the 1991 implementation of the local area network project.

SECTION 2. Ordinance No. 10179, Section 22, as amended is hereby amended by adding thereto and inserting therein the following:

Youth Services/Criminal Justice \$177,961

SECTION 3. Ordinance No. 9720, Section 36, as amended is hereby amended by adding thereto and inserting therein the following:

SPECIAL PROGRAMS-EXECUTIVE CONTINGENCY - From the Current Expense Fund there is hereby disappropriated from:

Special Programs-Executive Contingency (\$177,961)

SECTION 4. There is hereby approved and adopted an appropriation of \$53,553 to Current Expense and a disappropriation of \$53,553 from the Criminal Justice Fund to correct an error in Ordinance No. 10179.
