ORDINANCE NO.

AN ORDINANCE providing for the corrections of errors to the 1991 budget, making appropriations of \$23,200 to Unlimited GO Bond redemption Fund 850, \$9,255,000 to Pacific Medical Center Construction Fund 328, \$28,773 to Harborview Medical Center Construction - 1977 Fund (Fund 387), and disappropriating \$47,260 from Fund 3122, HMC Bond Administration Fund; amending Ordinance 9720, Sections 36, 49, 52, 68, and 94 as amended, and amending Ordinance No. 10179, Section 22, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted appropriatons of \$23,200 to Fund 850, Unlimited GO Bond redemption Fund 850 from fund balance, \$9,255,000 to Fund 328, Pacific Medical Center Construction Fund from fund Balance, \$28,773 to Fund 387, Harborview Medical Construction - 1977 Fund from fund balance, and various other off-setting appropriation adjustments to other funds and projects.
