ORDINANCE NO. **10502**

AN ORDINANCE appropriating \$598,407 to the Current Expense Fund from excess County Road Improvement District Guaranty Fund; appropriating \$523,407 to Transfer to Other Funds; appropriating \$75,000 to Special Programs; and amending Ordinance No. 10182, Section 25, 35 and 39, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved a transfer of \$598,407 in excess guaranty funds from the County Road Improvement District Guaranty Fund to the Current Expense Fund, in accordance with RCW 36.88.2335, which authorizes the transfer of excess County Road Improvement District Guaranty funds to the Current Expense Fund.

SECTION 2. There is hereby approved and adopted an appropriation of \$523,407 to Transfer to Other Funds from the unencumbered fund balance of the Current Expense Fund for transfer to the Airport Operating Fund in repayment of rent payments made by King County International Airport to the Current Expense Fund in 1988 and 1989.

SECTION 3. Ordinance No. 10182, Section 39, as amended, is hereby amended by adding thereto and inserting therein the following:
