

ORDINANCE NO. **10507**

AN ORDINANCE relating to the annexation of an area known as 81-73-3 to Southwest Suburban Sewer District.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as 81-73-3 Southwest Suburban Sewer District was filed with the county council effective May 14, 1992.

2. Southwest Suburban Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 90-66 concurred with the proposed annexation.

3. Southwest Suburban Sewer District did not need a Declaration of Non-significant Impact statement on the proposed annexation according to WAC

4. The county council held a public hearing on the 27th day of July, 1992 and has considered the criteria set forth in R.C.W. 56.02.060.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation of Southwest Suburban Sewer District of the area known as 81-73-3 and described in Section 4 herein is approved. This proposed annexation is consistent with R.C.W. 56.02.060 as described in the attached King County Council Annexation Report

SECTION 2. The Southwest Suburban Sewer District is the appropriate entity to serve the area proposed to be annexed.

SECTION 3. Completion of this annexation does not constitute county approval or disapproval of any other permits, franchises, certifications, or actions necessary to provide service to this annexation area, nor does it authorize sewer service in any area not designated as a "Local Service Area" by the King County Sewerage General Plan.

1 SECTION 4. The area known as 81-73-3 to be annexed is
2 described as follows:

3 Beginning at the Southwest corner of SE 14 of Section 17,
4 Township 23 North, Range 4 East, W.M.;

5 Thence Northerly along the West line of said Southeast 14
6 (Centerline of 8th Ave. South) to its intersection with the
7 North line of the South 1/2 of said Southeast 1/4 (Centerline
8 of South 140th Street);

9 Thence Easterly along said North line to its intersection with
10 the East right-of-way of Des Moines Way South;

11 Thence Southerly along said East right-of-way to its
12 intersection with the South line of said Southeast 14
13 (centerline South 144th Street);

14 Thence Westerly along said South line to the said Southwest
15 corner of SE 1/4 and the Point of Beginning.
