ORDINANCE NO.

AN ORDINANCE making a \$590,959 appropriation to numerous agencies for the purpose of paying for goods or services planned but neither delivered nor paid for during the previous fiscal year, and amending Ordinance No. 10182, Sections 15, 20, 21, 23, 36, 34, 35, 42 and 49 as amended.




