ORDINANCE NO. _____

AN ORDINANCE relating to cable communications, granting the extension of cable television franchises to All Points Associates, Inc., Edmonds Cable Company, Summit Communications, Inc., TCI of Auburn, Inc., TCI of Seattle, Inc., TCI Cablevision of Southwest Washington, Inc. and Viacom Cable.

STATEMENT OF FACTS

1. All Points Associates, Inc., currently holds two cable television franchises granted by King County. Those franchises will expire during November, 1993.

2. Edmonds Cable Company currently holds a cable television franchise granted by King County. That franchise will expire on April 18, 1993.

3. Summit Communications, Inc. currently holds a cable television franchise granted by King County. That franchise will expire on November 1, 1993.

4. TCI of Auburn, Inc., TCI of Seattle, Inc., and TCI Cablevision of Southwest Washington, Inc. currently hold television franchises granted by King County. Ten of these franchises will expire prior to August 1, 1993.

5. Viacom Cable currently holds cable television franchises granted by King County. Eleven of those franchises will expire prior to December 31, 1993.

6. The county wishes to extend these franchises to facilitate an orderly review of franchise renewals.

7. Each of these companies has agreed that its franchises be extended.

8. The council has determined that it is in the best interest of the citizens of King County to grant the franchise extensions listed below.

A hearing on this matter was held by the King County council on the 7th day of December, 1992.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The council hereby grants All Points Associates, Inc. an extension of franchise numbers 5598 and 5870 until December 31, 1993.

1 SECTION 2. The council hereby grants Edmonds Cable Company an
2 extension of franchise number 563 until December 31, 1993.

3 SECTION 3. The council hereby grants Summit Communications,
4 Inc. an extension of franchise number 5602 until December 31, 1993.

5 SECTION 4. The council hereby grants TCI of Auburn, Inc. an
6 extension of franchise numbers 565a, 591 and 1209 until August 1,
7 1993.

8 SECTION 5. The council hereby grants TCI of Seattle, Inc. an
9 extension of franchise numbers 547, 551, 552, 553, 562 and 599
10 until August 1, 1993.

11 SECTION 6. The council hereby grants TCI Cablevision of
12 Southwest Washington, Inc. an extension of franchise number 565
13 until August 1, 1993.

14 SECTION 7. The council hereby grants Viacom Cable an
15 extension of franchise numbers 546, 548, 549, 550, 559, 560, 561,
16 569, 659, 5175 and 5311 until December 31, 1993.

1 SECTION 8. These extensions are granted subject to the
2 condition that if within thirty (30) days of the council's passage
3 of this ordinance a franchisee fails to sign a franchise extension
4 agreement substantially in the same form as those agreements contained
5 in Exhibit A, which agreements are attached to and a part of this
6 ordinance, the franchise extension for that company shall be deemed
7 to be denied and any extension granted to that company by this
8 ordinance shall be null and void.


