AN ORDINANCE establishing public tour program fees collected on behalf of the Stadium Enterprise Fund; amending Ordinance 9715, Section 5, and K.C.C. 22.12.040, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance No. 9715 Section 5, and K.C.C. 22.12.040 are hereby amended as follows:

Tours.

Any person or organization taking a public tour of the Kingdome will pay the following, effective January 1, 1994:

A. Individual Rates

- Adults, ages 13-64 years . . . ((~~\$3.00~~)) \$4.00 per person  
(taxes included)
- Children, ages 6-12 years . . . ((~~\$1.50~~)) \$2.00 per person  
(taxes included)
- Senior citizens, over 64 years ((~~\$1.50~~)) \$2.00 per person  
(taxes included)
- Children (under 6 years) . . . . . FREE

B. Group Rates (at least 25 persons with advance scheduling).

- Adults, ages 13-64 years . . . . ((~~\$2.50~~)) 3.50 per person  
(taxes included)
- Children, ages 6-12 years . . ((~~\$1.25~~)) \$1.75 per person  
(taxes included)
- Senior citizens, over 64 years ((~~\$1.25~~)) \$1.75 per person  
(taxes included)
- Escorts assisting crowd control ((~~\$1.25~~)) \$1.75 per person  
(taxes included)

Financially Disadvantaged, Adults and Children (upon approval of authorized written request) \$ .50 per person (taxes included)

C. Seasonal or Promotional Tour Rates.

At the discretion of the director of the department of stadium administration, special rates may be established on a case by case basis for tours created for specific holidays, special events, and other Kingdome promotions.
