survey recorded in volume 45 of surveys on page 57, records of
King County, Washington, thence S 52°08'59" E along the north
boundary of said lot 29, as established per said recorded
survey, 76.02 feet to the true point of beginning; thence S
(~~09~~) 52° (~~56~~) 08' (~~29~~) 59" E 12.25 feet; thence (~~S~~) N 09°
56'29" E 5.74 feet; thence N 80°03'11" W 10.83 feet to the
true point of beginning.
