ORDINANCE NO. **11282**

AN ORDINANCE making a supplemental appropriation of \$515,573 to several departments for the renovation and operation of a dormitory at the North Rehabilitation Facility and amending Ordinance No. 11130, Sections 33, 83 and 117, as amended, and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted appropriations of \$344,708 to the division of alcoholism and substance abuse services, and \$375,573 to the department of adult detention from the current expense fund balance (\$375,573), and from the Criminal Justice Fund (\$140,000), for the renovation and operation of a dormitory at the North Rehabilitation Facility.

SECTION 2. Ordinance No. 11130, Section 44, is hereby amended by adding thereto and inserting therein the following:

DEPARTMENT OF ADULT DETENTION - From the Current Expense Fund, there is hereby appropriated to:

Department of Adult Detention \$ 375,573

The maximum number of additional FTEs for the Department of Adult Detention shall be: 0.75

SECTION 3. Ordinance No. 11130, Section 58, as amended is hereby amended as follows:

FACILITIES MANAGEMENT DIVISION - CJ - From the Criminal Justice Fund there is hereby appropriated to:

Facilities Management Division - CJ \$140,000

SECTION 4. Ordinance No. 11130, Section 83, is hereby amended by adding thereto and inserting therein the following:

ALCOHOLISM AND SUBSTANCE ABUSE - From the Alcoholism and

Substance Abuse Fund there is hereby appropriated to:

Alcoholism and Substance Abuse \$344,708

The maximum number of additional FTEs for the Division of Alcoholism and

Substance Abuse shall be: 4.80

SECTION 5. The county council finds as a fact and declares that an emergency exists and that this ordinance is necessary for the immediate preservation of public peace, health or safety or for the support of county government and its existing public institutions.
