ORDINANCE NO. **11449**

AN ORDINANCE relating to the annexation of an area generally bounded by South 192nd Street and east of 8th Avenue South, and formally known as annexation MS 94-1, to Midway Sewer District for sewer service.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of the property described above to Midway Sewer District for sewer service was filed with the county council effective July 20, 1994.

2. Midway Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 1994-8, concurred with the proposed annexation.

3. Midway Sewer District filed a Determination of Nonsignificance dated June 29, 1994, on the proposed annexation.

4. The county council held a public hearing on the 15<sup>th</sup> day of August, 1994, and has considered the criteria set forth in R.C.W. 56.02.070.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by Midway Sewer District of MS 94-1, an area generally bounded by South 192nd Street and east of 8th Avenue South, and described in Attachment A, is approved. This proposed annexation is consistent with R.C.W. 56.02.070.

SECTION 2. Midway Sewer District is the appropriate entity to provide sewer service to the area proposed to be annexed.

4 service to this annexation area.
