ORDINANCE NO. **11469**

AN ORDINANCE disappropriating \$218,831 from Squak/Issaquah Creek Trail Access and \$189,183 from the Cougar Mountain Access projects and appropriating \$408,014 to the newly-created Tibbetts Valley Trailhead Project, amending Ordinance 11130, Section 117, Attachment 2, as amended.

PREAMBLE:

1. The City of Issaquah has abandoned the 1989 open space bond Squak/Issaquah Creek Trail Access and Cougar Mountain Access Projects.
2. The King County Open Space Citizen Oversight Committee has recommended the creation of a new 1989 open space bond Tibbetts Valley Trailhead Project.
3. The King County Open Space Citizen Oversight Committee has recommended reallocation of \$408,014 from unanticipated 1989 Open Space Bond proceeds from the City of Issaquah Squak/Issaquah Creek Trail Access and Cougar Mountain Access Projects to the newly-created Tibbetts Valley Trailhead project within the same project category (as such term is defined in Ordinance 9071) from which the funds are realized.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted the disappropriation of \$218,831 from the Squak/Issaquah Creek Trail Access and \$189,183 from the Cougar Mountain Access projects and the appropriation of \$408,014 to the newly-created Tibbetts Valley Trailhead Project.

SECTION 2. Ordinance No. 11130, Section 117, Attachment 2, as amended is hereby amended by adding thereto and inserting therein the following:
