ORDINANCE NO. **11826**

AN ORDINANCE relating to the annexation of an area known as 92-1 to the Sammamish Plateau Water & Sewer District for the provision of water service.

STATEMENT OF FACT:

1. Intention of the proposed annexation of territory known as Annexation 92-1 to the Sammamish Plateau Water and Sewer District was filed with the county council effective May 23, 1995.

2. Sammamish Plateau Water and Sewer District has found the petition for annexation to be sufficient and has, by Resolution No. 1575, concurred with the proposed annexation.

3. Sammamish Plateau Water and Sewer District filed a Determination of Nonsignificance dated May 9, 1995, on the proposed annexation.

4. The county council held a public hearing on the day of 19th June, 19 95 and has considered the criteria set forth in R.C.W. 57.02.040.

SECTION 1. The annexation of territory known as Annexation 92-1 by the Sammamish Plateau Water and Sewer District, and described in Attachment A, is approved. This proposed annexation is consistent with R.C.W. 57.02.040.

SECTION 2. The Sammamish Plateau Water and Sewer District is the appropriate entity to provide water service to the area proposed to be annexed.

1 SECTION 3. Completion of this annexation does not
2 constitute county approval or disapproval of any other
3 permits, certifications, or actions necessary to provide
4 service to this annexation area.
