AN ORDINANCE appropriating \$215,000 to Eden Creek CIP Project No. 0N1005; 54,000 to CIP Monitoring Project No. 0D1787; \$35,000 to Peasley Canyon Drainage Improvements Project No. 0B1675; and \$237,000 to Camelot Park Drainage Improvements Project No. 0A1675 in the surface water management CIP Non-bond Subfund 329-2, from revenue from the Sammamish Plateau Sewer and Water District, unprogrammed bond proceeds, and available fund balance, and amending Ordinance 11578, Section 117, and Attachment 2, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$215,000 to Eden Creek CIP Project No. 0N1005; \$54,000 to CIP Monitoring Project No. 0D1787; \$35,000 to Peasley Canyon Drainage Improvements Project No. 0B1675; and \$237,000 to Camelot Park Drainage Improvements Project No. 0A1675 in the surface water management CIP Non-bond Subfund 329-2, from revenue from the Sammamish Plateau Sewer and Water District, unprogrammed bond proceeds, and available fund balance.

SECTION 2. Ordinance No. 11578, Section 117, as amended, is hereby amended by adding thereto and inserting therein the following:

From the several capital improvements project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment 2 of the ordinance.
