AN ORDINANCE making supplemental appropriations of \$1,593,885 and disappropriations of \$3,780,625 to several Solid Waste Capital Improvement Projects, and amending Ordinance 11578, Section 117 and Attachment 1B, as amended, and Section 118 and Attachment 2, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$1,593,885 to several solid waste Capital Improvement Projects from disappropriations of \$3,780,625 in solid waste Capital Improvement Projects.
