ORDINANCE NO. **12173**

AN ORDINANCE approving the Mirrormont Services 1992 Comprehensive Water System Plan.

PREAMBLE:

K.C.C. 13.24 requires approval of comprehensive plans for water purveyors as a prerequisite to the granting of right-of-way franchises and approval of right-of-way construction permits.

On March 24, 1993 the King County Utilities Technical Review Committee met to consider the plan and finding it consistent with K.C.C. 13.24 recommended approval.

The Mirrormont Services 1992 Comprehensive Water System Plan was approved by vote of the Board of Directors on September 25, 1995.

King County issued a Determination of Nonsignificance for the plan in accordance with the State Environmental Policy Act on March 30, 1993.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The Mirrormont Services 1992 Comprehensive Water System Plan, Attachment A, is hereby approved ((without conditions)) with the condition that as part of the requirement to demonstrate compliance with King County Comprehensive Plan policy F-208 in 1996, Mirrormont Services shall demonstrate compliance with the 1995 water usage




