ORDINANCE NO. **12447**

AN ORDINANCE relating to King County district court electoral district boundaries, amending Ordinance 10476 as amended, and K.C.C. 2.68.085.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Ordinance 10476 as amended, and K.C.C.

2.68.085 are hereby amended to read as follows:

2.68.085 Electoral District Boundaries. The Seattle electoral district shall be:

All of the area within the following described line:

All of the area within the boundary of the city of Seattle which includes to the centerline of the waters of Puget Sound and the centerline of Lake Washington.

The boundaries of the other electoral districts shall consist of the election precincts contained in Attachments A-H as listed below which are incorporated herein by reference, and which shall be retained officially on file in the division of records and elections, with copies maintained by the clerk of the council and the presiding judge of district court. The precincts listed in Attachment A-H consist of election precincts which have been established by King County council pursuant to K.C.C. 1.12.010:

- Federal Way Attachment C to Ordinance (~~11041~~) 12447.
