ORDINANCE NO. **12488**

AN ORDINANCE appropriating \$1,736,000 to transit capital program, Kingdome Intermodal Project, and amending Ordinance 12029, Section 110 and Attachment 2, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$1,736,000 to transit capital program, Kingdome Intermodal Project, from a Federal Transit Administration grant (\$1,620,000) and disappropriations of \$116,000 from the Electric Trolley Program (\$66,000) and the Passenger Facilities - 6YR Plan (\$50,000) for an examination of transportation problems in the south downtown area of Seattle in the vicinity of the Kingdome.

PROVIDED THAT: Prior to expending any funding on the final design phase of the Kingdome intermodal project, the county executive shall seek to increase the Port of Seattle's contribution to that phase of the project.

PROVIDED FURTHER THAT: No county funding shall be provided for final design or construction of the railroad grade crossing or Alaskan Way surface improvement elements of the Kingdome Intermodal Project.

SECTION 2. Ordinance 12029, Section 110, as amended, is hereby amended by adding thereto and inserting therein the following:

From the several capital improvement project funds there are hereby appropriated and authorized to be disbursed the following amounts for the specific projects identified in Attachment No. 2 of this ordinance.
