ORDINANCE NO. 12536

AN ORDINANCE relating to comprehensive planning and transportation; adopting amendments to the 1994 King County Comprehensive Plan, as amended; in compliance with the Washington State Growth Management Act, as amended; amending Ordinance 263, Article 2, Section 1, as amended, and K.C.C. 20.12.010.

PREAMBLE:

For the purpose of effective land use and transportation planning and regulation, the King County Council makes the following legislative findings:

1. King County has adopted the 1994 King County Comprehensive Plan, to meet the requirements of the Washington State Growth Management Act (GMA);
2. The GMA requires that the county's comprehensive plan contain a transportation element including a list of transportation improvements needed to meet existing and future growth needs, an assessment of financing capabilities to carry out the plan, and an amendment process to reflect changes in transportation, growth, and financing that have occurred since the previous plan or amendments. The GMA also requires that the county's development regulations be consistent with and implement the comprehensive plan and its amendments;
3. King County has studied and evaluated the 1997 Transportation Needs Report (TNR) and has considered the cumulative environmental impacts as part of the Addendum to the Supplemental Environmental Impact

1 impact fees for transportation improvements pursuant to R.C.W. 36.70A.070 and
2 82.02.050 through 82.02.080.

3 SECTION 2. Ordinance 263, Article 2, Section 1, as amended, and K.C.C. 20.12.010
4 is hereby amended by adding a new section to read as follows:

5 Comprehensive Plan adopted.

6 A. Under the provisions of the King County Charter, King County's constitutional
7 authority and pursuant to the Washington State Growth Management Act, R.C.W. 36.70A, the
8 1994 King County Comprehensive Plan is adopted and declared to be the Comprehensive Plan
9 for King County until amended, repealed, or superseded. The Comprehensive Plan shall be the
10 principal planning document for the orderly physical development of the county and shall be
11 used to guide subarea plans, functional plans, provision of public facilities and services, review
12 of proposed incorporations and annexations, development regulations, and land development
13 decisions.

14 B. The amendments to the 1994 King County Comprehensive Plan and the 1995 area
15 zoning amendments contained in King County Comprehensive Plan 1995 Amendments attached
16 as Appendix A to Ordinance 12061 are hereby adopted as amendments to the King County
17 Comprehensive Plan and adopted as the official zoning control for those portions of
18 unincorporated King County defined therein.

19 C. The amendments to the 1994 King County Comprehensive Plan contained in

1 SECTION 3. Severability. Should any section, subsection, paragraph, sentence, clause
2 or phrase of this ordinance be declared unconstitutional or invalid for any reason, such decisions
3 shall not affect the validity of the remaining portion of this ordinance.

1997 TNR CHANGE REPORT

INTRODUCTION

The Transportation Needs Report 1997 (TNR) is a comprehensive list of recommended improvements consistent with the King County Comprehensive Plan to serve countywide transportation needs. The TNR Change Report documents revisions, additions or deletions since the last adopted TNR (1996 Transportation Needs Report) and are reflected in the 1997 TNR. Projects that are the responsibility of the King County's Department of Transportation are shown in the TNR Change Report.

HOW TO USE THIS REPORT

No Change

The TNR Change Report is presented in matrix form. Each King County project is shown by their TNR project number and name. If a projects only change is a cost increase for inflation, then the first column titled "No changes from 96 to 1997" is marked with an 'X'. If the change is more than cost inflation, then one or more columns are marked. The following describes each column.

Project Dropped

If the second column titled "Project dropped from TNR" is marked with an 'X', it means that a project that was shown in the 1996 TNR is no longer represented in the 1997 TNR. There are several reasons why this occurs. The most common reason is the project was completed. A project is also be dropped from the TNR if its scope is combined and included as part of another project. A third possibility is the project need no longer exists because of substantial work by Maintenance forces.

New Project

The third column, "New project in 97" is marked if the project was not in the 1996 TNR and is presented for the first time. Most new projects identified here originate from one of the following sources: Traffic Engineering's High Accident Location (HAL) Report, improvements for the Quality Urban Environment (QUE) program, road damage caused by the floods that occurred earlier this year and pedestrian oriented projects focusing on serving Activity Centers within King County.

Change in Project Number

Column 4 identifies projects with project number changes. The original number from the 1996 TNR is shown in the comment column. The project number is used to track each project and changing a number is usually done only if a project is being phased. For instance, a project may have been only partially funded for construction within the 6 year program and thus maybe 'staged' to reflect the appropriate level of budgeted funding.

Change in Project Name and/or Limits

Any project marked in column 5 has either a revised project name or revised limits. This includes changing an obscure street name to one that is more formally used by the County. Changes in the project limits results from field survey information, Comprehensive Plan requirements or the CIP scoping process.

Change in Project Priority

Column 6 "Change in Project Priority" is marked for those projects whose scores changed enough to either raise or drop their priority standing from the 1996 TNR. All King County projects are scored through the adopted Priority Process on a yearly basis. Each project is categorized as a High, Medium or Low priority depending upon the score it receives. Priorities may change depending on the new scores that are calculated using updated information such as existing traffic volumes, level of service and accident rates. In addition, a field check was done to update physical road characteristic, land use and operational deficiency data.

Change in Responsible Agency

If a project in the 1997 TNR is now under a new jurisdiction, Column 7 "Change in Responsible Agency", is marked. This would also include adding new agencies to the project and/or deleting an agency from a project. Each year the County transmits a TNR project list to each of the local agencies, as well as WSDOT, to update their projects status. Due to annexations and incorporations within the County, the project responsibility can change.

Change in Project Scope

Column 8 is marked with an "X" if the project scope has changed. These changes may involve design modifications to reflect traffic, environmental or policy factors.

Change in Cost

Column 9 "Cost revised" is marked if King County's cost change for a project is a result of more than an increase for inflation. Revised cost estimates occur if a project scope is increased, decreased or more detailed engineering-level costs are available.

The last column briefly states the reason a change has occurred to a project.

SUMMARY

This report represents any changes that have occurred between the adopted 1996 TNR and the 1997 TNR. In order to determine the exact changes to a project, a comparison of the two actual documents is needed. The easiest way to track a project is by project number. If for instance, there is a change in scope to project N-9.1, turn to the Northshore chapter in both the 1996 TNR and the 1997 TNR and compare the differences in the text description for the scope of work. However, if a project number changes, then use the project number in the left column to find the project in the 1997 TNR and the comment column to find the same project in the 1996 TNR.
