The city of Auburn, Washington by Ordinance No.4928, has initiated the proposed annexation and expressed its intent to join the King County Rural Library District, finding that the public interest will be served thereby. Since there is no city-appointed library board, the state librarian has been notified per RCW 27.12.360.

City of Auburn Ordinance No.4928 does satisfy the provisions of RCW 27.12.010 (5), and 27.12.360 requesting the calling of an election to be held among the qualified voters therein.

3 AN ORDINANCE OF THE CITY OF AUBURN, WASHINGTON, DECLARING
4 THE INTENT OF THE CITY TO JOIN AND BE ANNEXED BY THE KING
5 COUNTY LIBRARY DISTRICT, REQUESTING THE CONCURRENCE OF THE
6 CITY'S LIBRARY BOARD OF TRUSTEES, AND REQUESTING THE COUNTY
7 COUNCIL TO CALL A SPECIAL ELECTION IN THE CITY AND THE DISTRICT
8 FOR FEBRUARY 4, 1997 FOR THE PURPOSE OF SUBMITTING THE
9 ANNEXATION TO THE VOTERS.

10 WHEREAS, RCW 35.02.130 authorizes the City Council of the City of
11 Auburn to submit ballot propositions to the voters of the City in order to authorize
12 annexation of the City by King County Rural Library District (District) effective
13 immediately.

14 WHEREAS, pursuant to RCW 27.12.360, the process of annexation must
15 be initiated by an ordinance of the City stating the City's intent to join the District
16 and finding that the public interest will be served thereby; and

17 WHEREAS, the City of Auburn Library Board has been notified of this
18 proposed ordinance pursuant to RCW 27.12.360; now, therefore,

19 THE CITY COUNCIL OF THE CITY OF AUBURN, WASHINGTON, DO
20 ORDAIN AS FOLLOWS:

21 Section 1. Declaration of Intent and Finding. The City of Auburn hereby

2 Section 2. Transmittal to District - Request for Concurrence. Pursuant to
3 RCW 27.12.360, the City Clerk is hereby directed to forward a certified copy of
4 this Ordinance to the Board of Trustees of the King County Rural Library District.
5 The City Council requests that the Board of Trustees concur in the proposed
6 annexation of the City by the District.

7 Section 3. Transmittal to County Council - Request for Special Election.
8 Pursuant to RCW 27.12.360 and .370, if the Board of Trustees concurs in the
9 annexation, the City Clerk is hereby directed to notify, and to send a certified
10 copy of this Ordinance and a copy of the District's concurrence, to the King
11 County Council. The King County Council is hereby requested to call and
12 conduct a special election to be held in the City of Auburn on February 4, 1997,
13 which is the next date provided in RCW 29.13.010 and is not less than forty-five
14 (45) days from the date of this declaration and finding. The King County Council
15 is also requested to give notice of the election as provided for in RCW
16 29.27.080. The purpose of the election shall be to submit to the qualified voters
17 within the City of Auburn a ballot proposition in substantially the following form.

20 Shall the City of Auburn, Washington, be annexed
21 to and be a part of the King County Library
 District?

1 Section 4. The Mayor is hereby authorized to implement such administrative
2 procedures as may be necessary to carry out the directions of this legislation.

3 Section 5. This Ordinance shall take effect and be in force five (5) days from and
4 after its passage, approval and publication, as provided by law.

RESOLUTION OF THE BOARD OF TRUSTEES OF THE KING COUNTY RURAL LIBRARY DISTRICT CONCURRING, SUBJECT TO CONDITION, WITH THE ANNEXATION OF THE CITY OF AUBURN INTO THE KING COUNTY RURAL LIBRARY DISTRICT.

WHEREAS, the City of Auburn has passed an ordinance which initiates the process for a special election to determine whether the Auburn shall be annexed into the King County Rural Library District, and

WHEREAS, RCW 27.12 provides a process for the annexation of cities and towns into rural library districts, and

WHEREAS, the Board of Trustees believes that the annexation would be in the best interest of all involved, and

WHEREAS, the several steps to be taken to meet the boundary changes requirements necessitate the taking of this action by the Library District.
