AN ORDINANCE making a supplemental appropriation of \$710,920 to Grants to fund the Drug Court Program in the Department of Judicial Administration, and amending Ordinance 12029, Section 88, as amended.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted a supplemental appropriation of \$710,920 to grants from a Byrne Grant through the Department of Community, Trade and Economic Development, (\$430,920); the city of Seattle (\$100,000); and the Sheriff and Police Chiefs' Association (\$180,000) to fund the Drug Court Program in the department of judicial administration. Grant File 396/6250.

SECTION 2. Ordinance 12029, Section 88, as amended, is hereby amended by adding thereto and inserting therein the following:
