AN ORDINANCE appropriating \$6,223,072 to the Solid Waste Operating budget and providing for the removal of an operating expenditure contra placed in the 1997 Adopted Budget by Council Proviso and increasing the Solid Waste Division's (SWD) 1997 CIP appropriation by \$3,153,107 and amending Ordinance 12538, Sections 88, 107 and Attachment 2.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. There is hereby approved and adopted an appropriation of \$6,223,072 to the Solid Waste Fund and \$3,153,107 to the various Solid Waste CIP funds.

SECTION 2. Ordinance 12538, Section 88, as amended, is hereby amended by adding thereto and inserting therein the following:

SECTION 3. Ordinance 12538, Section 107, as amended, is hereby amended by adding thereto and inserting therein the following:
