ORDINANCE NO. **12879**

AN ORDINANCE related to road redesignation; changing the name of a portion of 241st Avenue Southeast to "Southeast 471st Street."

PREAMBLE:

In 1995, King County department of transportation constructed a new road between Southeast 472nd Street and Southeast 468th Street. The new street running primarily south to north is designated as 241st Avenue Southeast. An existing connection between 241st Avenue Southeast and Southeast 471st Street running in a northwesterly direction is also designated 241st Avenue Southeast. There are now two separate streets with the same designation causing confusion and difficulty for emergency vehicles attempting to locate homes in an emergency situation. Additionally, the postal service has encountered delivery problems due to the current addressing scheme.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The approximately 400 feet of roadway commonly known as 241st Avenue Southeast lying southerly and adjacent to lots 3, 4, and 5 Plat of Glacier Vista as recorded in volume 77 of plats, page 23, records of King County, Washington as described on attachment A to this ordinance and shown on attachment B to this ordinance, is hereby redesignated in its entirety as "Southeast 471st Street."

SECTION 2. The 20-day notice requirement for affected property owners in ordinance 10915, section 2, shall be met.

SECTION 4. The director of the department of development and environmental services shall accomplish any necessary address change notifications within ninety days of the effective date of this ordinance.
