ORDINANCE NO. **12881**

AN ORDINANCE relating to no shooting areas, establishing a no shooting area near North Bend, and adding a new section to K.C.C. 12.68.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The shooting of firearms is prohibited and a no-shooting area is established near North Bend within the Grizzly and River Bend voting precincts and described as follows:

A. The area bounded by Interstate 90 on the north, 468<sup>th</sup> Avenue Southeast on the east, SE 156<sup>th</sup> Place on the southeast, across the Snoqualmie River and along Camp Waskowitz's southern property line on the southwest, and

Camp Waskowitz's western property line on the west, including the waters of the South Fork of the Snoqualmie River encompassed by these boundaries.

**RE:** Certification of Petition in Support of No Shooting Area - North Bend - Camp Waskowitz

**REF:** (a) K.C.C. 12.68.010 - Petitions to create or dissolve no shooting areas

In response to your memo dated September 30, 1996, the Division of Records and Elections has examined the signatures contained on the petition filed in support of the proposed no shooting area located in the vicinity of North Bend - Camp Waskowitz, pursuant to reference (a).

The area described in the petition is somewhat vague, but from what can be determined, encompasses parts of two precincts, GRIZZLY and RIVER BEND. Most of the area is within GRIZZLY, as are all the signers of the petition. The northwestern "panhandle" of the area, that between I-90 and the South Fork of the Snoqualmie River and west of approximately 454th Avenue SE as extended, is in RIVER BEND Precinct. However, there are no registered voters in that particular part of the area. Therefore, whether signatures of voters in RIVER BEND Precinct is required is for the Council to determine.

Of the 11 signatures that were compared against those on file with this Division, 9 were determined to be registered voters of GRIZZLY precinct. Two of the signers are registered voters, but not at the address shown on the petition. Since that number fails to meet the ten signatures per precinct required to certify, it is determined that the petition is not sufficient. However, if the petitioners not presently registered at the address shown on the petition authorize us to transfer their voter registration to that address, the petition would then appear to meet the requirements of reference (a) to be valid.

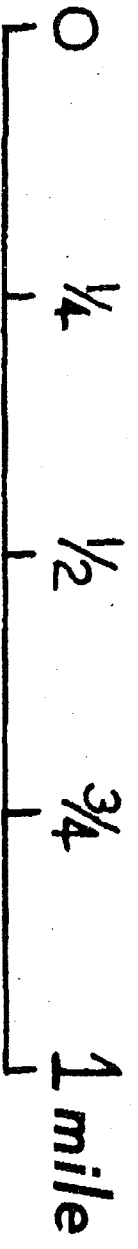
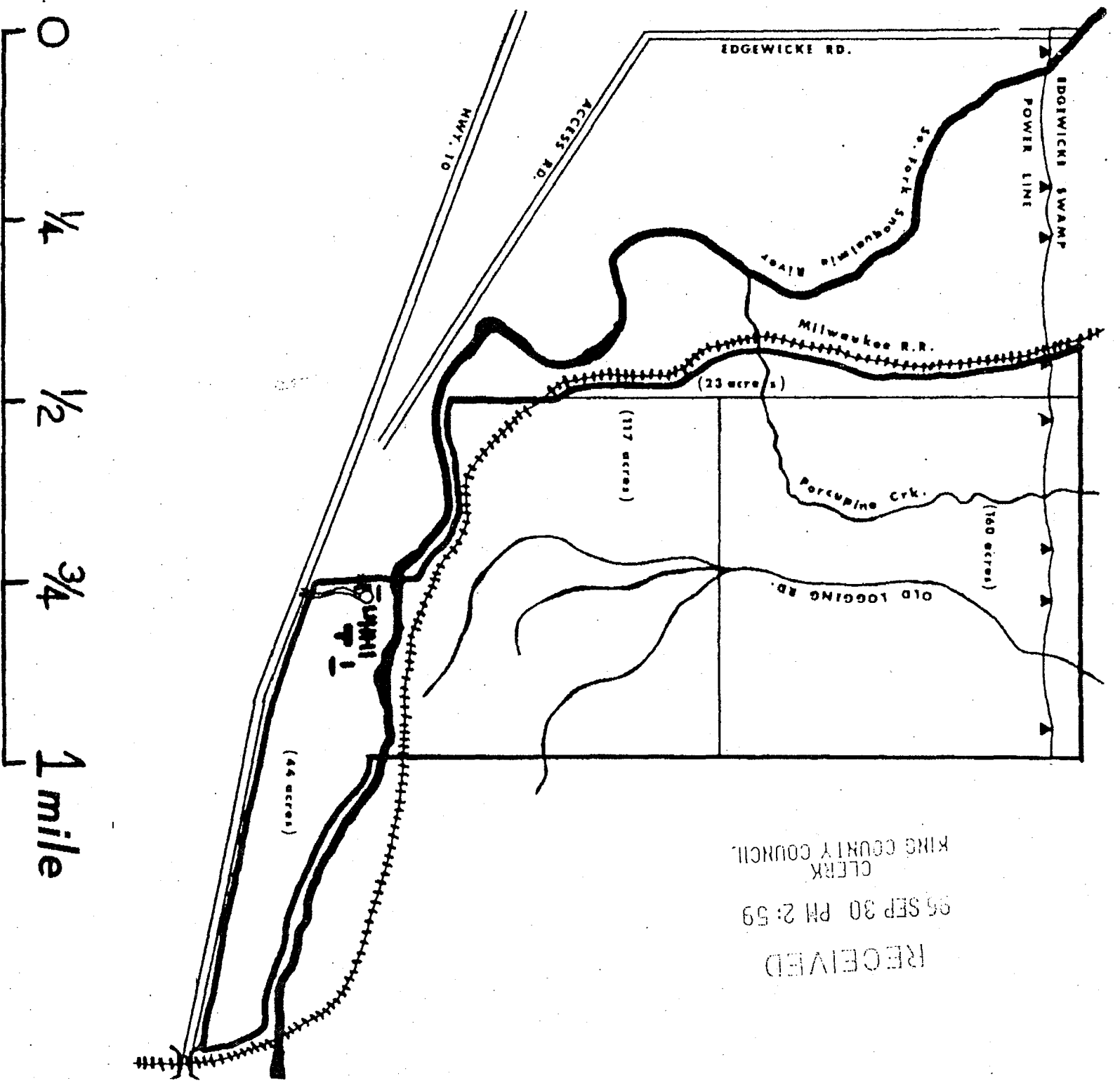
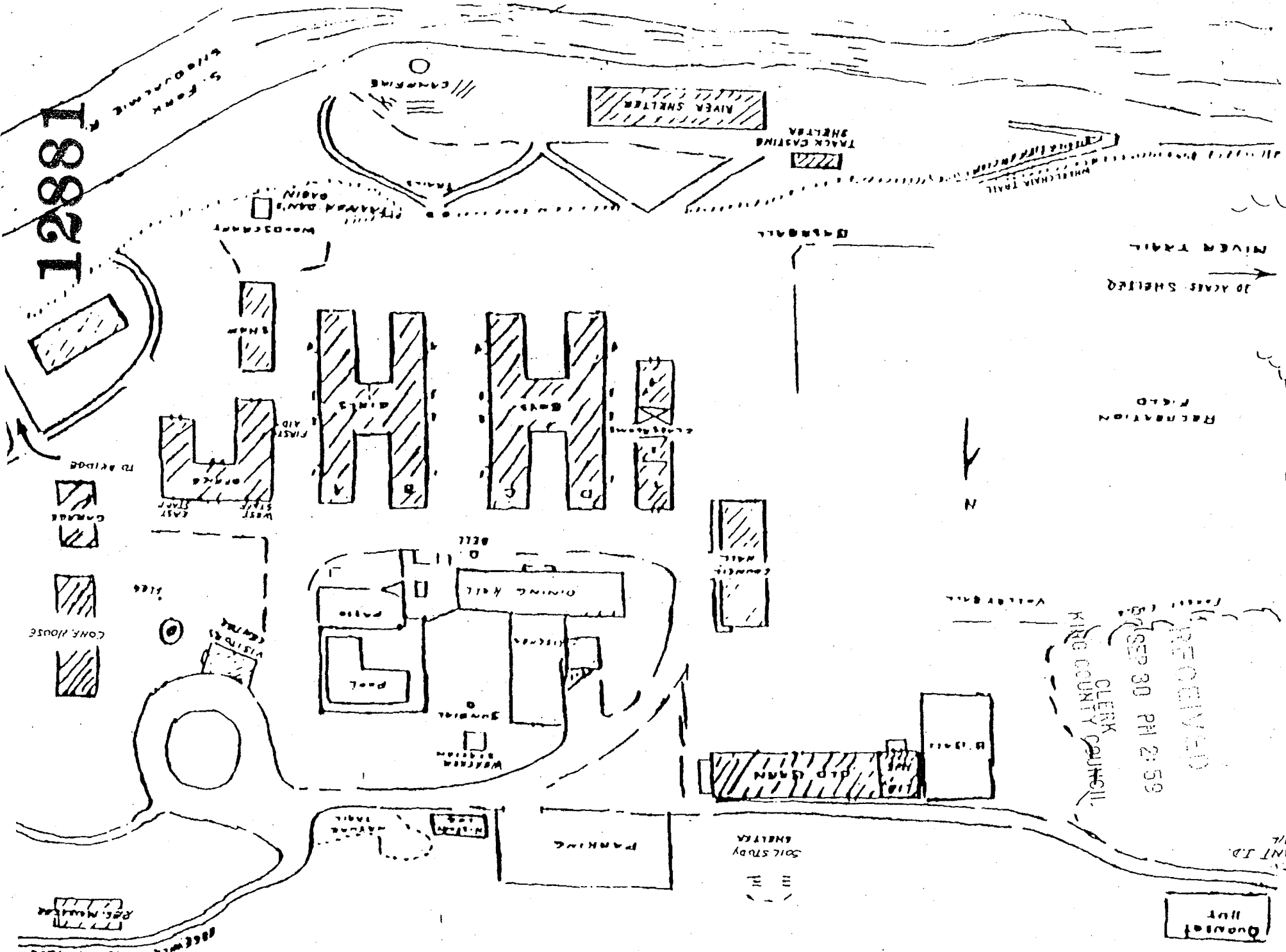


Exhibit: 1 Map of Entire Camp Waskowitz Area
