5 ORDINANCE NO. **13010**

6 AN ORDINANCE relating to the Washington State Public Water
7 System Coordination Act (RCW 70.116), ratifying the 1996 update
8 to the East King County Coordinated Water System Plan, and
9 recommending final approval by the Washington state department
10 of health.

11 FINDINGS:

- 13 1. The King County council ratified the east King County Coordinated Water System
14 Plan (CWSP) with approval of Ordinance 9462 on May 29, 1990.
- 15
- 16 2. Pursuant to RCW 70.116, the east King County CWSP is required to be updated
17 every five years.
- 18
- 19 3. An addendum to the east King County CWSP was ratified by the King County
20 council with approval of Ordinance 11213 on January 31, 1994. The addendum
21 addressed new regional water supply options and satellite system management. In
22 addition, the addendum discussed water service and fire flow standards in rural
23 areas, a matter subsequently referred to a technical committee of the Growth
24 Management Planning Council.

- 26 4. The 1996 update to the east King County CWSP (Update) addresses seven issues:
27 a) water demand forecasts;
28 b) boundaries among water purveyors;
29 c) regional water supply options;
30 d) conservation programs;
31 e) minimum design standards for water systems;
32 f) amendments to RCW 70.116; and
33 g) relationships among the Growth Management Act, King County
34 comprehensive plan, and the CWSP.

- 36 5. The Water Utility Coordinating Committee (WUCC) established by the county for
37 the purpose of developing a CWSP approved the update on November 14, 1996.
- 38
- 39 6. Pursuant to K.C.C. 13.24, the Utilities Technical Review Committee (UTRC)
40 reviewed the update on June 11, 1997 for consistency with adopted county land use
41 plans and policies. The UTRC conditionally approved the update provided that the
42 WUCC shall meet to discuss the following issues and ensure that they are addressed
43 in the next update to the CWSP:

- 1 a) identification of the water supply factors that will cause mandatory
- 2 conservation and curtailment actions to be required by the WUCC and carried out by
- 3 the purveyors in the east King County critical water supply service area;
- 4 b) description of specific actions to be required by the WUCC and carried out by
- 5 the purveyors in the east King County critical water supply service area to address
- 6 water shortages.

8 7. Ratification means certification by the county legislative authority that the CWSP

9 is consistent with the county adopted land use plans and policies.

11 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

12 SECTION 1. The 1996 update to the east King County Coordinated Water System Plan,

13 attached as Exhibit A, is hereby ratified in accordance with the requirements of chapter 70.116

14 RCW.

15 SECTION 2. The King County council finds that the next update to the CWSP should

16 address the following issues:

- 17 a) identification of the water supply factors that will cause mandatory conservation and
- 18 curtailment actions to be required by the WUCC and carried out by the purveyors in the east King
- 19 County critical water supply service area;
- 20 b) description of specific actions to be required by the WUCC and carried out by the
- 21 purveyors in the east King County critical water supply service area to address water shortages.

1 SECTION 3. The King County council recommends approval of the update by the
2 Washington state department of health.
