ORDINANCE NO. **13219**

AN ORDINANCE relating to the annexation of an area known as the McBee Annexation Area to King County Water District No. 119 for the purpose of providing water service.

STATEMENT OF FACT:

1. A notice of intention proposing the annexation of an area known as the McBee Annexation Area to King County Water District No. 119 for water service was filed with the County Council effective March 31, 1998.
2. King County Water District No. 119 has found the petition for annexation to be sufficient and has, by Resolution No. 333 concurred with the proposed annexation.
3. King County Water District No. 119 filed a Determination of Nonsignificance dated February 2, 1998, on the proposed annexation.
4. The Utilities Technical Review Committee recommended County Council approval of the proposed annexation on April 15, 1998.
5. The County Council held a public hearing on the day of May 11, 1998 and has considered the criteria set forth in R.C.W. 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 119 of the area known as the McBee Annexation Area and described in Attachment A, is approved. This proposed annexation is consistent with RCW 57.02.040.

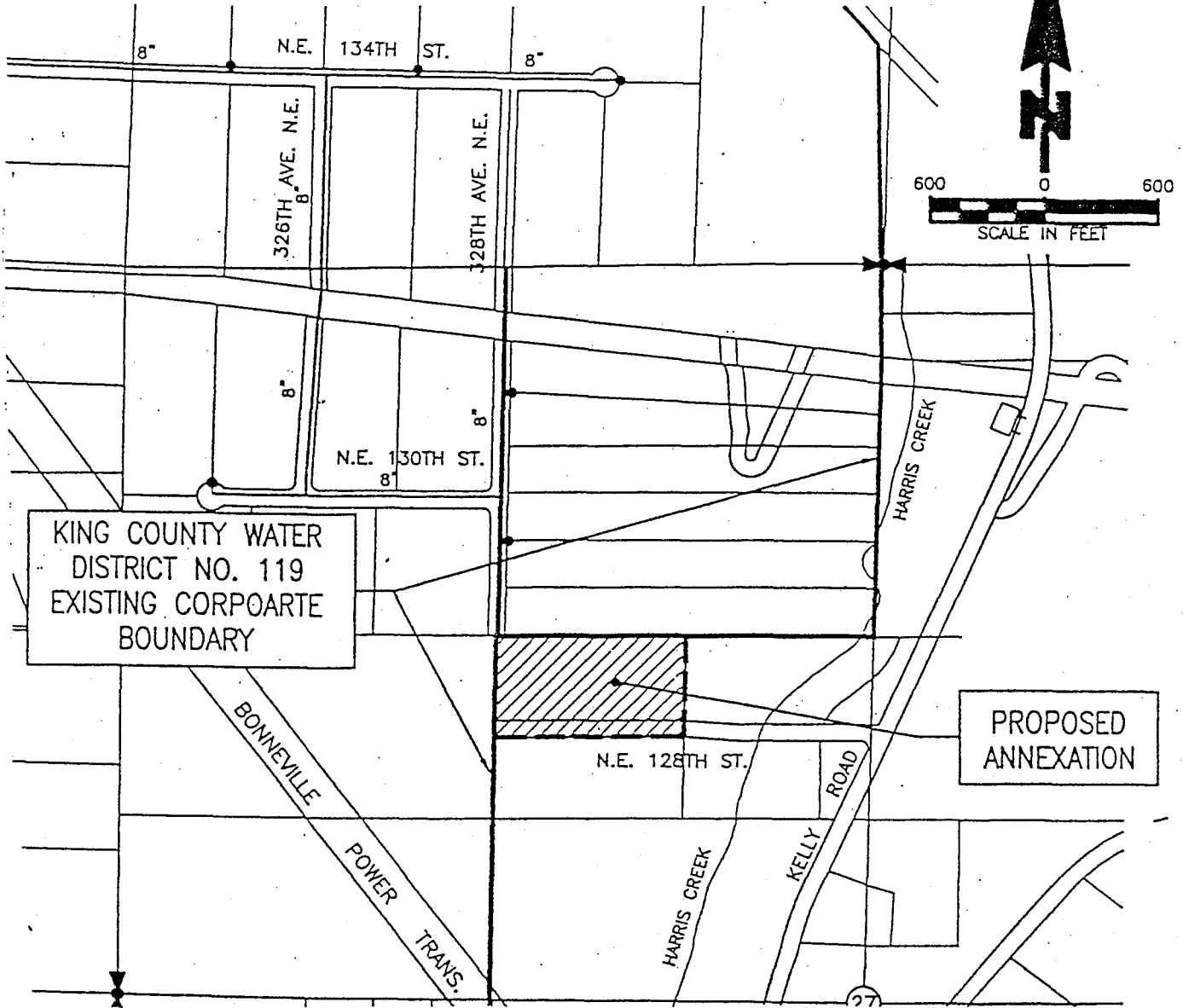
