ORDINANCE NO. **13220**

AN ORDINANCE relating to the annexation of an area known as the Olson Annexation Area to King County Water District No. 119 for the purpose of providing water service.

STATEMENT OF FACTS:

1. A notice of intention proposing the annexation of an area known as Olson Annexation Area to King County Water District No. 119 for water service was filed with the county council effective April 20, 1998.
2. King County Water District No. 119 has found the petition for annexation to be sufficient and has concurred with the proposed annexation in Resolution No. 335.
3. King County Water District No. 119 filed a Determination of Nonsignificance on the proposed annexation dated April 1, 1998.
4. The Utilities Technical Review Committee recommended county council approval of the proposed annexation on May 5, 1998.
5. The county council held a public hearing on the day of June 15, 1998 and has considered the criteria set forth in RCW 57.02.040.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. The annexation by King County Water District No. 119 of the area known as the Olson Annexation Area and described in Attachment A is approved. This proposed annexation is consistent with RCW 57.02.040.

EXHIBIT A

LEGAL DESCRIPTION OF  
OLSON ANNEXATION AREA

The following parcels of property in King County, Washington:

PARCEL A: That portion of the South Half of the North Half of the Northeast Quarter of the Southwest Quarter of Section 27, Township 26 North, Range 7 East, Willamette Meridian, in King County, Washington, lying Easterly of Kelly Road.

PARCEL B: The North Half of the North Half of the Northeast Quarter of the Southwest Quarter, lying easterly of the Kelly County Road, Section 27, Township 26 North, Range 7 East, Willamette Meridian.

PARCEL C: That portion of the Northwest Quarter of the Southeast Quarter lying westerly of the Lake Joy Road, as the same is described in an Easement from Weyerhaeuser Timber Co. To King County, Washington, dated July 27, 1939; all in section 27, Township 26 North, Range 7 East, Willamette Meridian.

PARCEL D: That portion of Kelly County Road and Lake Joy County Road lying in the North Half of the North Half of the South Half of Section 27, Township 26 North, Range 7 East, Willamette Meridian.
