AN ORDINANCE making an emergency appropriation of \$20,000 to the Department of Public Health for the purpose of funding the King County Natural Medicine Clinic, disappropriating \$20,000 from the Community Services Division; amending the 1998 Budget Ordinance, Ordinance 12926, Sections 41, 43, and 81, and declaring an emergency.

## BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. With adoption of the 1998 budget ordinance, Ordinance 12926, \$90,000 remained unfunded for the King County Natural Medicine Clinic putting into jeopardy vital research analysis. Through the corrections ordinance, Ordinance 13271, \$70,000 was funded. In order to complete the research analysis, it is necessary for the county to enact this emergency ordinance and fund the remaining \$20,000. For the above stated reasons, the county council finds as a fact and declares an emergency exists and that this ordinance is necessary for the immediate preservation of public peace, health, or safety or for the support of county government and existing public institutions.
