1 ORDINANCE NO. **13420**

2 AN ORDINANCE approving a franchise for Vashon Sewer  
3 District to construct, operate and maintain a sewer system in  
4 council district 8, and authorizing the executive to execute the  
5 franchise agreement.

6 STATEMENT OF FACTS:

- 7 1. The Vashon Sewer District has filed an application for a franchise in  
8 council district 8 to construct, operate and maintain a sewer system to  
9 serve primarily residential with some multi family and commercial areas  
10 in accordance with RCW 36.55.010 and K.C.C. chapter 6.27.
- 11 2. The district's comprehensive plan was approved on October 26, 1994, by  
12 King County council Ordinance 11546. In addition, this ordinance  
13 authorizes the district under its Resolution No. 290 to provide sanitary  
14 sewer service to three areas identified by the State of Washington  
15 Department of Ecology as severe public health hazard areas. The areas  
16 designated for sewer service includes Spring Beach, Bunker Trail and  
17 Beulah Park/Cove facilities.
- 18 3. The application has been referred to the relevant county departments for  
19 review.

1 4. The King County executive has recommended approval of the franchise.

2 5. The Utilities Technical Review Committee reviewed and approved the  
3 districts franchise, legal description and area map on October 26, 1994.

4 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

5  
6 SECTION 1. The granting of a franchise to the Vashon Sewer District to

7 construct, operate and maintain a sewer system within King County is hereby approved.

8 The King County executive is authorized to enter into and execute the sewer system

9 franchise, which by this reference is fully incorporated herein. Said franchise shall include

10 all of the general and special conditions required by the county.



INTRODUCED AND READ for the first time this 30<sup>th</sup> day of November, 1998.




