AN ORDINANCE OF THE MILTON CITY COUNCIL DECLARING ITS INTENT TO JOIN AND BE ANNEXED TO THE PIERCE COUNTY RURAL LIBRARY DISTRICT; REQUESTING THE CONCURRENCE OF THE PIERCE COUNTY RURAL LIBRARY DISTRICT BOARD OF TRUSTEES; REQUESTING THE PIERCE COUNTY COUNCIL AND THE KING COUNTY COUNCIL TO CALL A SPECIAL ELECTION IN THE CITY ON THE PROPOSITION OF WHETHER THE CITY SHOULD BE ANNEXED TO THE PIERCE COUNTY RURAL LIBRARY DISTRICT; AND REPEALING ORDINANCE NO. 1402, APPROVED FEBRUARY 1, 1999.

WHEREAS, the City Council desires to declare its intent to join and be annexed to the Pierce County Rural Library District and to submit a ballot proposition to the voters of the City to authorize annexation of the City by Pierce County Rural Library District; and

WHEREAS, pursuant to RCW 27.12.360 the process of such annexation is initiated by an ordinance of the City Council stating the City's intent to join the Pierce County Rural Library District and finding that the public interest will be served thereby; and

WHEREAS, pursuant to RCW 27.12.360, the City has submitted this ordinance to the Milton Memorial Library Board for its review and recommendations; and

WHEREAS, the Milton Memorial Library Board reviewed this ordinance and recommended that it be adopted by the City Council; and

WHEREAS, having reviewed the options for providing library service to the residents of the City, the City Council finds that the public interest will best be served by annexation of the City to the Pierce County Rural Library District; and

WHEREAS, if the Pierce County Rural Library District concurs with the annexation, notification thereof shall be transmitted to the Pierce County Council, which shall then call a special election to be held in the City at the time and in the manner provided in RCW 27.12.370; now, therefore,

The City Council of the City of Milton do ordain as follows:

Section 1. Declaration of Intent. The City of Milton hereby declares its intent to join and be annexed to the Pierce County Rural Library District.

Section 2. Request for Concurrence of Library District. Pursuant to RCW 27.12.360, the City Council requests that the Board of Trustees of the Pierce County Rural Library District concur with the proposed annexation of the City to the Pierce County Rural Library District. The City Clerk/Treasurer is authorized and directed to forward a certified copy of this Ordinance to the Board of Trustees of the Pierce County Rural Library District.

Section 3. Request for Special Election. The Pierce County Council and the King County Council are hereby requested to pass a resolution setting a special election to be held in the City on September 14, 1999, for the purpose of submitting to the qualified voters of the City the proposition of whether the City should annex to the Pierce County Rural Library District. The Pierce County Council and the King County Council are also requested to give notice of the election as provided in RCW 29.27.080. The proposition to be submitted at the special election shall be in the form of a ballot title as follows:



Pursuant to RCW 27.12.360 and 27.12.370, if the Board of Trustees of the Pierce County Rural Library District concurs in the annexation, the City Clerk/Treasurer is authorized and directed to notify, and to send a certified copy of this ordinance and a copy of the Pierce County Rural Library District's concurrence, to the Pierce County Council and to the King County Council.

Section 6. Annexation. If a majority of persons voting on the annexation proposition vote in favor of annexation, then the City of Milton shall be annexed to and constitute a part of the Pierce County Rural Library District effective as provided by law.


Section 7. Repealer. That Ordinance No. 1402, approved February 1, 1999, is hereby repealed.

ORDINANCE NO. 13585

AN ORDINANCE calling for a special election for the purpose of submitting to the affected voters, for their ratification or rejection, the determination of whether or not the City of Milton shall join and be annexed to the Pierce County Rural Library; and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

SECTION 1. Findings of fact:

- A. The City of Milton desires to declare its intention to be annexed to the Pierce County Rural Library District;
- B. Pursuant to RCW 27.12.360, the process of the annexation is initiated by an ordinance of the city council stating the city’s intent to join the Pierce County Rural Library District and finding that the public interest will be served thereby;
- C. Pursuant to RCW 27.12.360, the city has submitted that ordinance to the Milton Memorial Library Board for its review and recommendations;
- D. The Milton Memorial Library Board reviewed the resolution and recommended that it be adopted by the city council;

1 E. Having reviewed the options for providing library services to the residents  
2 of the City of Milton, the Milton City Council passed Ordinance No. 1410 declaring its  
3 intent to join and be annexed to the Pierce County Rural Library District;

4 F. The board of trustees of the Pierce County Rural Library District passed  
5 Resolution No. 99-11 on April 8, 1999, which concurred with the annexation of the City of  
6 Milton into the Rural Library District pursuant to RCW 27.12.360; and

7 G. RCW 27.12.370 states "The county legislative authority or authorities shall  
8 by resolution call a special election to be held in such city or town at the next date  
9 provided in RCW 29.13.010 but not less than forty-five days from the date of the  
10 declaration of such finding . . . ."

11 SECTION 2. A special election shall be held on the 14th day of September, 1999,  
12 within the City of Milton. The ballot proposition shall be in substantially the following  
13 form in accordance with RCW 27.12.370:

14 "Shall the City of Milton be annexed to and be a part of the Pierce County Rural  
15 Library District?

18 SECTION 3. If a majority of persons voting on the annexation proposition vote in  
19 favor of annexation, the City of Milton shall be annexed to and constitute a part of the

21 SECTION 4. The manager of the division of records and elections shall cause  
22 notice of the proposed annexation to be published in accordance with the State  
23 Constitution and general law and placed on the ballot at the September 14, 1999, election,


