2 AN ORDINANCE concurring with a recommendation and  
3 decisions of the hearing examiner; concurring with the  
4 recommendation to approve, subject to conditions (modified), an  
5 application for a special use permit, as provided for in King County  
6 zoning resolution no. 25789, as amended, for a wastewater  
7 treatment facility, designated land use services file no. L99UU001,  
8 as submitted by the Vashon Sewer District; and concurring with the  
9 decisions to approve, subject to conditions (modified), a public  
10 agency and utility exception from sensitive areas regulations  
11 (wetlands, streams, steep slope, landslide hazard, erosion hazard,  
12 and flood hazard), designated lurd file no. L99UT001, and a  
13 shorelines substantial development permit to construct facilities  
14 within and near Puget Sound, designated lurd file no. L99SH001,  
15 as submitted by the Vashon Sewer District.

16 BE IT ORDAINED BY THE COUNCIL OF KING COUNTY:

17 SECTION 1. This ordinance does hereby adopt and incorporate herein as its findings and  
18 conclusions:

19 A. The findings and conclusions contained in the report and recommendation of the  
20 hearing examiner dated August 26, 1999, which was filed with the clerk of the council September  
21 9, 1999, to approve, subject to conditions (modified), an application for a special use permit, as  
22 provided for in King County zoning resolution no. 25789, as amended, for a wastewater treatment  
23 facility, designated lurd file no. L99UU001, as submitted by the Vashon Sewer District; and

24 B. The findings and conclusions contained in the report and decision of the hearing  
25 examiner dated August 26, 1999, which was filed with the clerk of the council September 9, 1999,  
26 to approve, subject to conditions (modified), the application for:
