14 **SECTION 1.** The King County council, under RCW 57.04.065, approves the




15 change in the name of King County water district no. 83 to "Lake Forest Park Water





WHEREAS, there is confusion among the general populous over what area the District serves, and




WHEREAS, the Commissioners wish to clarify the name of the District with a name that is more descriptive of our physical location, and
